

1 An ordinance recommended by the Board of Public Service authorizing the 2013 St. Louis
2 Works and the 50/50 Sidewalk Programs City Wide providing for the construction and reconstruction of
3 gutters, streets, driveways, spot curbs, sidewalks, alleys, traffic controls, beautification, tree planting,
4 resurfacing and related engineering adjustments listed herein, appropriating \$5,000,000.00 from the
5 Street Improvement Fund; containing sections for description of the work, approval of plans and
6 specifications, work and material guarantees, estimated costs from City funds and supplemental
7 agreements and reversion authorizations, applicable state and federal wage rate requirements, equal
8 opportunity provisions, the Mayor's Executive Orders, contract advertising statutes, and a public work
9 emergency clause.

10 **BE IT ORDAINED BY THE CITY OF ST LOUIS AS FOLLOWS:**

11 **Section One.** The Board of Public Service is hereby authorized to let contracts, employ and pay for
12 labor, wages, consultants, equipment, computer programs and hardware, employees, supervision and
13 otherwise provide for designing, constructing, reconstructing, replacing, beautifying, traffic controls,
14 landscaping, paving, resurfacing, and related engineering adjustments to the streets, alleys and public
15 rights-of-way in the twenty-eight wards of the City for the 2013 St. Louis Works and the 50/50
16 Sidewalk Programs as evidenced by Exhibit "A" attached hereto and on file in the City Register's
17 Office.

18 **Section Two.** There is hereby appropriated Five Million Dollars (\$5,000,000.00) which is the
19 aggregate estimated cost of the City's share of the Public Work authorized herein, from funds set
20 aside and placed to the credit of the Street Improvement Fund established by Ordinance 55852,
21 approved March 31, 1971 and Ordinance 55964, 55965, and 55966, approved July 1, 1971 and any
22 other subsequent ordinance, as amended and the Comptroller is authorized to draw warrants, accept

1 gifts, make payments from the general fund and the Street Improvement Funds as they become
2 available throughout the year to pay any portion of the cost of the labor, contracts, materials,
3 equipment, computer programs, and public improvements contained and authorized herein by this
4 St. Louis Works Construction Ordinance.

5 **Section Three.** The work provided for herein shall be carried out in accordance with detailed plans
6 and specifications and necessary supplemental agreements to be approved by the Board of Public
7 Service before bids are advertised therefore.

8 **Section Four.** If let by contract said contract, or contracts, shall provide that the contractor, or
9 contractors, doing said work shall guarantee and keep in repair all of the work, equipment and
10 materials used in connection therewith for a term of at least one year, commencing on the date of
11 acceptance of the work by the City.

12 **Section Five.** All construction contracts let under authority of this ordinance shall provide that no
13 less than the prevailing hourly rate of wages in the City of St. Louis, as determined by the
14 Department of Labor and Industrial Relations of the State of Missouri (Section 290.210 through
15 290.340 RSMo 1995) for each craft or type of work needed in the actual labor on the jobs herein
16 authorized, as well as the general prevailing rate of pay for legal holidays and overtime work shall be
17 paid to all workers. All contracts let in connection with the work provided for herein shall be subject
18 to, and in conformance with, all statutes of the State of Missouri and the Charter and Code of the
19 City of St. Louis.

20 **Section Six.** Any revenue received by the City from the 50/50 Sidewalk Program, gifts or
21 cooperation agreements shall be deposited to the credit of the individual wards, as established in
22 Ordinance 62206.

23 **Section Seven.** To allow full participation and to help in the St. Louis Works Program, and to
24 accomplish the overall goals for the improvements in all twenty-eight wards of the City; the Board

1 of Public Service and the Comptroller are authorized to enter into supplemental agreements with
2 various Federal, State, Local, and private entities to provide for funds, work, site dedications, and
3 acquisitions by negotiations and condemnations.

4 **Section Eight.** All specifications approved by the Board of Public Service and contracts let under
5 authority of this ordinance shall provide for compliance with the Presidential Executive Order 11246
6 and 379 on Equal Opportunity and the Mayor's Executive Order of December 22, 1986 on selection
7 of experts and consultants. The Board of Public Service shall establish goals on all contracts of no
8 less than twenty five (25%) participation by minority subcontractors and material suppliers and no
9 less than five percent (5%) participation by women subcontractors and suppliers. It is the policy of
10 the City of St. Louis to pursue the goal of having thirty percent of apprenticeship positions and
11 twenty-five percent of all other positions involved in construction work in the St. Louis metropolitan
12 area filled by residents of the City of St. Louis of these positions it is intend that one half be filled by
13 members of minority groups and ten percent (10%) by females. The City will make a determination
14 if the contractor has made a good faith effort to achieve these goals.

15 **Section Nine.** All sections of this ordinance are and shall be severable. In the event that any section
16 of this ordinance is found to be illegal, the remaining sections of this ordinance shall remain valid
17 and to the benefit of the City.

18 **Section Ten.** All advertisements for bids pursuant to this Ordinance shall be subject to Section
19 8.250, RSMo 1995.

20 **Section Eleven.** This being an ordinance to provide for public work and improvements, it is hereby
21 declared to be an emergency measure and shall become effective immediately upon its passage and
22 approval by the Mayor.
