

1 **BOARD BILL NO.285 INTRODUCED BY ALDERWOMAN DIONNE FLOWERS**

2 An ordinance, recommended by the Board of Public Service of the City of St. Louis, authorizing
3 and directing the Department of Streets, on behalf of the City of St. Louis, to enter into a contract
4 between the City of St. Louis and Union Electric Company, doing business as Ameren Missouri,
5 a Missouri corporation, for street and outdoor lighting service for certain facilities within the
6 territorial limits of the City of St. Louis, subject to amendment, for a period of ten (10) years
7 commencing on the date of execution of the contract, in substantially the form and as attached
8 hereto as Exhibit 1 with its Exhibit A, Appendix 1, and Appendix 2; and containing an
9 emergency clause.

10 WHEREAS, Union Electric Company is authorized to place wires, tubes, and cables conveying
11 electricity for the production of light and power along streets, alleys, and public places of the
12 City of St. Louis pursuant to a franchise agreement authorized by a previous ordinance;

13 WHEREAS, Union Electric Company currently provides lighting service to certain City of St.
14 Louis-owned facilities and Union Electric Company-owned facilities for outdoor and street
15 lighting to the public within the territorial limits of the City of St. Louis (see Appendix 1 to
16 Exhibit 1 attached hereto and made a part hereof);

17 WHEREAS, Union Electric Company is willing to provide a ten percent (10%) discount per the
18 tariff in effect at the time (see Appendix 2 to Exhibit 1 attached hereto and made a part hereof) to
19 the City of St. Louis, as a franchised municipal customer, if a contract is in place allowing for
20 such lighting service;

21 WHEREAS, the City of St. Louis and Union Electric Company desire to enter into a contract,
22 attached hereto and made a part hereof as Exhibit 1 with its Exhibit A, Appendix 1, and
23 Appendix 2, wherein Union Electric Company will provide street and outdoor lighting service to

1 the City of St. Louis within the territorial limits of the City of St. Louis subject to applicable
2 rates and discounts in affect at the time.

3 **BE IT ORDAINED BY THE CITY OF ST. LOUIS AS FOLLOWS:**

4 **SECTION ONE.** The Department of Streets, on behalf of the City of St. Louis, is
5 hereby authorized and directed to enter into a contract with Union Electric Company, doing
6 business as Ameren Missouri, a Missouri corporation, for street and outdoor lighting service for
7 certain facilities within the territorial limits of the City of St. Louis, subject to amendment, for a
8 period of ten (10) years commencing on the date of execution of the contract, in substantially the
9 form attached hereto and incorporated by reference herein as Exhibit 1 with its Exhibit A,
10 Appendix 1, and Appendix 2.

11 **SECTION TWO.** Emergency Clause. This being an ordinance for the preservation of
12 public peace, health and safety, is hereby declared an emergency measure within the meaning of
13 Sections 19 and 20 of Article IV of the Charter of the City of St. Louis and therefore this
14 ordinance shall become effective immediately upon its passage and approval by the Mayor.
