3 An ordinance, recommended and approved by the Board of Estimate and Apportionment
4 and the Board of Public Service of the City of St. Louis (the "Board of Public Service"),
5 authorizing and directing the Mayor on behalf of the City of St. Louis, to apply for and enter into
6 an execute an Agreement with the U.S. Department of Housing and Urban Development for a
7 grant to fund the removal and replacement of concrete sidewalks, sod and tree planting, and
8 installation of precast concrete tree grates on the west side of Gravois Avenue between Gertrude
9 and Eichelberger Streets; establishing a public works and improvement project for the design
10 and construction of streetscape enhancements, including but not limited to the installation of
11 concrete sidewalks, sod and tree planting, and precast concrete tree grates on the west side of
12 Gravois Avenue between Gertrude and Eichelberger Streets; (the "Gravois Avenue Streetscape
13 Improvements Project") and authorizing and directing the City of St. Louis (the "City") through
14 its Board of Public Service to let contracts and provide for the design, construction, materials,
15 and equipment, for the Gravois Avenue Streetscape Improvements Project, authorizing the
16 Board of Public Service to employ labor and consultants, pay salaries, fees and wages, acquire
17 real property interests for the Gravois Avenue Streetscape Improvements Project, to enter into
18 supplemental agreements with other governmental and private agencies, and to otherwise
19 provide for the design and construction of the streetscape enhancements for the Gravois Avenue
20 Streetscape Improvements Project all in accordance with the grant entered into for said Project;
21 with any contract containing sections for: description of the work, material guarantees, estimated
22 expenditure allocations, fund reversion authorization, applicable federal and state wage rate
23 requirements, equal opportunity provisions, the Mayor's Executive Orders, and contract
24 advertising statutes; requiring that all work provided for herein shall be carried out in accordance

1 with detailed plans and specifications adopted and approved by the Board of Public Service
2 before bids are advertised therefor; directing that all construction contracts let by authority of
3 this Ordinance provide for state prevailing wages requirements including prevailing wage
4 holiday and overtime pay and compliance with all applicable statutes of the State of Missouri,
5 the City Charter and the Revised Code of the City, 1994, as amended; requiring all specifications
6 approved by the Board of Public Service and contracts let by authority of this Ordinance provide
7 for compliance with the Mayor's Executive Orders on Equal Opportunity and maximum
8 MBE/WBE/DBE utilization goals, except when superseded or prohibited by federal or state law
9 or regulation; requiring all advertisements for bids pursuant to this Ordinance be subject to the
10 provisions of Section 8.250 RSMo., as amended; and appropriating the total estimated cost of
11 Seventy Four Thousand Five Hundred Fifty Eight Dollars (\$74,558) for said Project from the
12 grant entered into pursuant to this Ordinance; authorizing and directing the Comptroller of the
13 City to draw warrants from time to time and disburse funds appropriated by this ordinance and to
14 disburse grant funds in accordance with the Grant and upon certification of vouchers by the
15 President of the Board of Public Service; authorizing the Board of Public Service to accept on
16 behalf of the City monetary donations from other governmental agencies and others to assist in
17 paying for the work authorized by this Ordinance; and containing an emergency clause.

18 BE IT ORDAINED BY THE CITY OF ST. LOUIS AS FOLLOWS:

19 SECTION ONE: The Mayor is hereby authorized and directed, on behalf of the City of
20 St. Louis, to apply for, to enter into and execute all necessary documents with the U.S.
21 Department of Housing and Urban Development for a grant of \$74,558.00 to fund the design and
22 construction of streetscape improvements, including but not limited to the installation of
23 concrete sidewalks, sod and tree planting, and precast concrete tree grates on the west side of
24 Gravois between Gertrude and Eichelberger Streets.

1 SECTION TWO: There is hereby authorized a public works and improvement project
2 for the design and construction of streetscape improvements, including but not limited to the
3 installation of concrete sidewalks, sod and tree planting, and precast concrete tree grates on the
4 west side of Gravois between Gertrude and Eichelberger Streets (the "Gravois Avenue
5 Streetscape Improvements Project").

6 SECTION THREE: The City of St. Louis (the "City") by and through its Board of Public
7 Service (the "Board of Public Service") is hereby authorized and directed to let contracts and
8 provide for the design, construction, materials, and equipment, for the Gravois Avenue
9 Streetscape Improvements Project, to employ labor and consultants, pay salaries, fees and
10 wages, acquire real property interests for the Gravois Avenue Streetscape Improvements Project,
11 to enter into supplemental agreements with other governmental and private agencies, and to
12 otherwise provide for the design and construction of the streetscape improvements for the
13 Gravois Avenue Streetscape Improvements Project, all in accordance with the grant entered into
14 for said Project, with any contracts containing sections for: description of the work, material
15 guarantees, estimated expenditure allocations, fund reversion authorization, applicable state
16 wage rate requirements, equal opportunity provisions, the Mayor's Executive Orders, and
17 contract advertising statutes.

18 SECTION FOUR: The work provided for herein shall be carried out in accordance with
19 detailed plans and specifications to be adopted and approved by the Board of Public Service
20 before bids are advertised therefor.

21 SECTION FIVE: All construction contracts let under authority of this Ordinance shall
22 provide that no less than the prevailing hourly rate of wages in the City, as determined in
23 accordance with the Department of Labor and Industrial Relations of the State of Missouri

1 (Sections 290.210 through 290.340 RSMo. 2000, as amended,) for each craft or type of work
2 needed in the actual labor on the jobs herein authorized, as well as the general prevailing rate of
3 pay for legal holidays and overtime work shall be paid to all workers on the Gravois Avenue
4 Streetscape Improvements Project. All contracts let in connection with the construction provided
5 for herein shall be subject to, and in conformance with all applicable statutes of the State of
6 Missouri and the City Charter and Revised Code of the City 1994, as amended.

7 SECTION SIX: All specifications approved by the Board of Public Service and
8 contracts let under the authority of this Ordinance shall provide for compliance with the Mayor's
9 Executive Orders on Equal Opportunity and maximum MBE/WBE/DBE utilization goals, except
10 when otherwise superseded or prohibited by federal or state law or regulation.

11 SECTION SEVEN: All advertisement for bids pursuant to this Ordinance shall be
12 subject to Section 8.250 RSMo. 2000, as amended.

13 SECTION EIGHT: The total estimated cost of the Gravois Avenue Streetscape
14 Improvements Project is Seventy Four Thousand Five Hundred Fifty Eight Dollars which
15 amount is hereby from said Grant entered into pursuant to this Ordinance to be expended for the
16 payment of costs for work and services authorized herein.

17 SECTION NINE: The Comptroller of the City is hereby authorized and directed to draw
18 warrants from time to time and disburse funds appropriated by this ordinance and is further
19 authorized and directed to disburse grant funds upon the signature and certification of vouchers
20 by the President of the Board of Public Service.

21 SECTION TEN: The Board of Public Service is hereby authorized to accept on behalf of
22 the City monetary donations from other governmental agencies and others to assist in paying for
23 the work authorized in this Ordinance.
