

1 **BOARD BILL NO. 229**

**INTRODUCED BY ALDERMAN CHARLES Q. TROUPE**

2 An ordinance approving a blighting study and redevelopment plan dated November 16,  
3 2010 for the 5101-33 Labadie Ave. Redevelopment Area (as further defined herein, the “Plan”)  
4 after finding that said Redevelopment Area (“Area”) is blighted as defined in Section 99.320 of the  
5 Revised Statutes of Missouri, as amended (the "Statute" being Sections 99.300 to 99.715 RSMo  
6 inclusive, as amended); containing a description of the boundaries of the Area in the City of St.  
7 Louis ("City"), attached hereto and incorporated herein as Attachment "A", finding that  
8 redevelopment and rehabilitation of the Area is in the interest of the public health, safety, morals  
9 and general welfare of the people of the City; approving the Plan attached hereto and incorporated  
10 herein as Attachment "B", pursuant to Section 99.430 RSMo, as amended; finding that no property  
11 in the Area may be acquired by the Land Clearance for Redevelopment Authority of the City of St.  
12 Louis (“LCRA”), a public body corporate and politic created under Missouri law, through the  
13 exercise of eminent domain; finding that some of the property within the Area is occupied, and the  
14 Redeveloper(s) (as defined herein) shall be responsible for providing relocation assistance pursuant  
15 to the Plan to any eligible occupants displaced as a result of implementation of the Plan; finding  
16 that financial aid may be necessary to enable the Area to be redeveloped in accordance with the  
17 Plan; finding that there shall be available up to a fifteen (15) year real estate tax abatement; and  
18 pledging cooperation of this St. Louis Board of Aldermen (“Board”) and requesting various  
19 officials, departments, boards and agencies of the City to cooperate and to exercise their respective  
20 powers in a manner consistent with the Plan; and containing a severability clause.

21 WHEREAS, the predominance of defective or inadequate street layout, insanitary or unsafe  
22 conditions, deterioration of site improvements, improper subdivision or obsolete platting,  
23 inadequate or outmoded design and conditions which endanger life or property by fire and other

1 causes, or any combination of such factors, retards the provision of housing accommodations or  
2 constitutes an economic or social liability or a menace to the public health, safety, morals or  
3 welfare in the present condition and use of the Area and such conditions are beyond remedy and  
4 control solely by regulatory process in the exercise of the police power and cannot be dealt with  
5 effectively by ordinary private enterprise without the aids provided in the Statute; and

6 WHEREAS, this Board has considered the “Blighting Study and Redevelopment Plan for  
7 the 5101-33 Labadie Ave. Redevelopment Area” dated November 16, 2010, consisting of a Title  
8 Page; a Table of Contents Page, eighteen (18) numbered pages including Exhibits “A” – “F”  
9 attached hereto and incorporated herein as Attachment “B” (“Plan”); and based on the information  
10 in the Plan, specifically the Blighting Report in Exhibit “F” to the Plan, considered each parcel of  
11 property in the Area and found the preponderance of the Area to be blighted, and

12 WHEREAS, there is a need for the LCRA to undertake the redevelopment of the Area as a  
13 land clearance project under the Statute, pursuant to plans by or presented to the LCRA under  
14 Section 99.430.1 (4) RSMo, as amended; and

15 WHEREAS, the LCRA has, after considering each individual parcel of property in the Area  
16 and finding the Area to be blighted, approved the Plan and recommended approval of the Plan to  
17 the Planning Commission of the City of St. Louis (“Planning Commission”) and to this Board; and

18 WHEREAS, it is desirable and in the public interest that a public body, the LCRA,  
19 undertake and administer the Plan; and

20 WHEREAS, the LCRA and the Planning Commission have made and presented to this  
21 Board the studies and statements required to be made and submitted by Section 99.430 RSMo, as  
22 amended, and this Board has been fully apprised by the LCRA and the Planning Commission of the  
23 facts and is fully aware of the conditions in the Area; and

1           WHEREAS, the Plan has been presented and recommended by LCRA and the Planning  
2 Commission to this Board for review and approval; and

3           WHEREAS, a general plan has been prepared and is recognized and used as a guide for the  
4 general development of the City and the Planning Commission has advised this Board that the Plan  
5 conforms to that general plan; and

6           WHEREAS, under the provisions of the Statute, it is required that this Board take such  
7 actions as may be required to approve the Plan; and

8           WHEREAS, this Board has duly considered the reports, recommendations and  
9 certifications of the LCRA and the Planning Commission; and

10          WHEREAS, the Plan prescribes land use and street and traffic patterns which may require,  
11 among other things, the vacation of public rights-of-way, the establishment of new street and  
12 sidewalk patterns or other public actions; and

13          WHEREAS, this Board is cognizant of the conditions which are imposed on the  
14 undertaking and carrying out of a redevelopment project, including those relating to prohibitions  
15 against discrimination because of race, color, creed, national origin, sex, marital status, age, sexual  
16 orientation or physical handicap; and

17          WHEREAS, in accordance with the requirements of Section 99.430 RSMo, as amended,  
18 this Board placed public notices in a newspaper of general circulation in the City that a public  
19 hearing would be held by this Board on the Plan, and a hearing was held at the time and place  
20 designated in those notices and all those who were interested in being heard were given a  
21 reasonable opportunity to express their views; and

22          WHEREAS, it is necessary that this Board take appropriate official action respecting the  
23 approval of the Plan.

1           **NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF ST. LOUIS AS**  
2 **FOLLOWS:**

3           **SECTION ONE.** There exists within the City of St. Louis ("City") a blighted area, as  
4 defined by Section 99.320 of the Revised Statutes of Missouri, as amended (the "Statute" being  
5 Sections 99.300 to 99.715 inclusive, as amended) described in Attachment "A", attached hereto and  
6 incorporated herein, known as the 5101-33 Labadie Ave. Area ("Area"). The existence of  
7 deteriorated property and other conditions constitutes an economic or social liability to the City and  
8 presents a hazard to the health and well-being of its citizens. These conditions, therefore, qualify  
9 the Area as blighted within the meaning of Section 99.320(3) RSMo, as amended, and are  
10 evidenced by the Blighting Report attached as Exhibit "F" ("Blighting Report") to the Blighting  
11 Study and Redevelopment Plan for the Area dated November 16, 2010 which is attached hereto,  
12 and labeled Attachment "B" and incorporated herein by reference ("Plan").

13           **SECTION TWO.** The redevelopment of the Area, as provided by the Statute, is  
14 necessary and in the public interest, and is in the interest of the public health, safety, morals and  
15 general welfare of the people of the City.

16           **SECTION THREE.** The Area qualifies as a redevelopment area in need of redevelopment  
17 under the provision of the Statute, and the Area is blighted as defined in Section 99.320 of the  
18 Statute.

19           **SECTION FOUR.** The Plan (including the Blighting Report) having been duly reviewed  
20 and considered, is hereby approved and incorporated herein by reference, and the President or  
21 Clerk of this St. Louis Board of Aldermen ("Board") is hereby directed to file a copy of the Plan  
22 with the Minutes of this meeting.

23           **SECTION FIVE.** The Plan is feasible and conforms to the general plan for the City.

1           **SECTION SIX.** The financial aid provided and to be provided for financial assistance  
2 pertaining to the Area is necessary to enable the redevelopment activities to be undertaken in  
3 accordance with the Plan, and the proposed financing plan for the Area is feasible.

4           **SECTION SEVEN.** The Plan for the Area will afford maximum opportunity, consistent  
5 with the sound needs of the City as a whole, for the redevelopment of the Area by private  
6 enterprise, and private redevelopments to be sought pursuant to the requirements of the Statute.

7           **SECTION EIGHT.** The Plan provides that the Land Clearance for Redevelopment  
8 Authority of the City of St. Louis ("LCRA") may acquire no property in the Area by the exercise of  
9 eminent domain.

10           **SECTION NINE.** Some of the property within the Area is currently occupied. All  
11 eligible occupants displaced by the Redeveloper(s)(as defined in Section Twelve, below) shall be  
12 given relocation assistance by the Redeveloper(s) at its expense, in accordance with all applicable  
13 federal, state and local laws, ordinances, regulations and policies.

14           **SECTION TEN.** The Plan gives due consideration to the provision of adequate public  
15 facilities.

16           **SECTION ELEVEN.** In order to implement and facilitate the effectuation of the Plan  
17 hereby approved, it is found and determined that certain official actions must be taken by this  
18 Board and accordingly this Board hereby:

19           (a) Pledges its cooperation in helping to carry out the Plan;

20           (b) Requests the various officials, departments, boards and agencies of the City, which  
21 have administrative responsibilities, likewise to cooperate to such end and to execute their  
22 respective functions and powers in a manner consistent with the Plan; and

1 (c) Stands ready to consider and take appropriate action upon proposals and measures  
2 designed to effectuate the Plan.

3 **SECTION TWELVE.** All parties participating as owners or purchasers of property in the  
4 Area for redevelopment ("Redeveloper(s)") shall agree for themselves and their heirs, successors  
5 and assigns that they shall not discriminate on the basis of race, color, creed, national origin, sex,  
6 marital status, age, sexual orientation or physical handicap in the sale, lease, or rental of any  
7 property or improvements erected or to be erected in the Area or any part thereof and those  
8 covenants shall run with the land, shall remain in effect without limitation of time, shall be made  
9 part of every contract for sale, lease, or rental of property to which Redeveloper(s) is a party, and  
10 shall be enforceable by the LCRA, the City and the United States of America.

11 **SECTION THIRTEEN.** In all contracts with private and public parties for redevelopment  
12 of any portion of the Area, Redeveloper(s) shall agree:

13 (a) To use the property in accordance with the provisions of the Plan, and be bound by  
14 the conditions and procedures set forth therein and in this Ordinance;

15 (b) That in undertaking construction under the agreement with the LCRA and the Plan,  
16 bona fide Minority Business Enterprises (as further defined below, "MBEs") and Women's  
17 Business Enterprises ("as further defined below ("WBEs") will be solicited and fairly considered  
18 for contracts, subcontracts and purchase orders;

19 (c) To be bound by the conditions and procedures regarding the utilization of MBEs  
20 and WBEs established by the City;

21 (d) To adhere to the requirements of the Executive Order of the Mayor of the City,  
22 dated July 24, 1997, as has been extended.

1 (e) To comply with applicable requirements of Ordinance No. 60275 of the City (First  
2 Source Jobs Policy, as codified at St. Louis City Revised Code Chapter 3.90);

3 (f) To cooperate with those programs and methods supplied by the City with the  
4 purpose of accomplishing, pursuant to this paragraph, minority and women subcontractors and  
5 material supplier participation in the construction pursuant to the Plan. The Redeveloper(s) will  
6 report semi-annually during the construction period the results of its endeavors under this  
7 paragraph, to the Office of the Assistant Director-Certification and Compliance of the City and the  
8 President of this Board; and

9 (g) That the language of this Section Thirteen shall be included in its general  
10 construction contract and other construction contracts entered into directly by Redeveloper(s).

11 The term MBE shall mean a sole proprietorship, partnership, corporation, profit or non-  
12 profit organization owned, operated and controlled by Minority Group Member(s) (as defined  
13 below) who have at least fifty-one percent (51%) ownership therein. The Minority Group  
14 Member(s) must have operational and management control, interest in capital and earnings  
15 commensurate with their percentage of ownership. The term Minority Group Member(s) shall  
16 mean persons legally residing in the United States who are Black, Hispanic, Native American  
17 (American Indian, Eskimo, Aleut or Native Hawaiian), Asian Pacific American (persons with  
18 origins from Japan, China, the Philippines, Vietnam, Korea, Samoa, Guam, U.S. Trust Territory of  
19 the Pacific Islands, Laos, Cambodia or Taiwan) or Asian Indian American (persons with origins  
20 from India, Pakistan or Bangladesh). The term WBE shall mean a sole proprietorship, partnership,  
21 corporation, profit or non-profit organization owned, operated and controlled by a woman or  
22 women having at least fifty-one percent (51%) ownership. The woman or women must have

1 operational and managerial control, interest in capital and earnings commensurate with their  
2 percentage of ownership.

3 The term "Redeveloper(s)" as used in this Section shall include heirs, successors in interest,  
4 and assigns.

5 **SECTION FOURTEEN.** A Redeveloper may seek ten (10) year real estate tax abatement pursuant  
6 to Sections 99.700 – 99.715, Revised Statutes of Missouri 2000, as amended, upon applications as provided  
7 therein. Such real estate tax abatement shall not include any Special Business District, Neighborhood  
8 Improvement District, Commercial Improvement District, or any other similar local taxing district created in  
9 accordance with Missouri law, whether now existing or later created.

10 In lieu of the ten (10) year abatement outlined above, and if a low-income tax credit  
11 program is implemented to finance particular parcels' redevelopment, a Redeveloper which is an  
12 urban redevelopment corporation formed pursuant to Chapter 353 of the Missouri Statutes shall  
13 hereby be entitled to real property ad valorem tax abatement, which shall not include any Special  
14 Business District, Neighborhood Improvement District, Commercial Improvement District, or  
15 any other single local taxing district created in accordance with Missouri law, whether now  
16 existing or later created, for a total period of up to fifteen (15) years from the commencement of  
17 such tax abatement, in accordance with the following provisions of this Plan. If no low income  
18 tax credit program has been implemented to finance the redevelopment of a particular parcel,  
19 then that parcel shall only be eligible to receive tax abatement for a period of up to ten (10)  
20 years.

21 If property in the Area is sold by the LCRA to an urban redevelopment corporation formed  
22 pursuant to Chapter 353 of the Missouri Statutes, or if any such corporation shall own property  
23 within the Area, then for up to the first ten (10) years after the date the redevelopment corporation

1 shall acquire title to such property, taxes on such property shall be based upon the assessment of  
2 land, exclusive of any improvements thereon, during the calendar year two (2) years prior to the  
3 calendar year during which such corporation shall have acquired title to such property. In addition  
4 to such taxes, any such corporation shall for up to the same ten (10) year period make a payment in  
5 lieu of taxes to the Collector of Revenue of the City of St. Louis in an amount based upon the  
6 assessment on the improvements located on the property during the calendar year two (2) years prior  
7 to the calendar year during which such corporation shall have acquired title to such property. If  
8 property shall be tax-exempt because it is owned by the LCRA and leased to any such corporation,  
9 then such corporation for up to the first ten (10) years of such lease shall make payments in lieu of  
10 taxes to the Collector of Revenue of the City in an amount based upon the assessment on the  
11 property, including land and improvements, during the calendar year two (2) years prior to the  
12 calendar year during which such corporation shall lease such property.

13 For the ensuing period of up to five (5) years following the original period stated above, any  
14 such corporation shall pay taxes and payments in lieu of taxes as provided above in an amount based  
15 upon fifty percent (50%) of the then normal assessment of the land and improvements. This  
16 provision shall only apply to taxes on parcels with redevelopment financed in part by low income  
17 tax credit programs. Thereafter any such corporation shall pay the full amount of taxes.

18 All payments in lieu of taxes shall be a lien upon the property and, when paid to the  
19 Collector of Revenue of the City shall be distributed as all other property taxes. These partial  
20 tax relief and payment in lieu of taxes provisions, during up to said fifteen (15) year period, shall  
21 inure to the benefit of all successors in interest in the property of the redevelopment corporation,  
22 so long as such successors shall continue to use such property as provided in this Plan and in any

1 contract with the LCRA. In no event shall such benefits extend beyond fifteen (15) years after  
2 the redevelopment corporation shall have acquired title to the property.

3 **SECTION FIFTEEN.** Any proposed modification which will substantially change the  
4 Plan must be approved by this Board in the same manner as the Plan was first approved.  
5 Modifications which will substantially change the Plan include, but are not necessarily limited to,  
6 modifications on the use of eminent domain, to the length of tax abatement, to the boundaries of the  
7 Area, or to other items which alter the nature or intent of the Plan.

8 The Plan may be otherwise modified (e.g. urban design regulations, development schedule)  
9 by the LCRA, provided that such revisions shall be effective only upon the consent of the Planning  
10 Commission of the City.

11 **SECTION SIXTEEN.** The sections of this Ordinance shall be severable. In the event that  
12 any section of this Ordinance is found by a court of competent jurisdiction to be invalid, the  
13 remaining sections of this Ordinance are valid, unless the court finds the valid sections of the  
14 Ordinance are so essential and inseparably connected with and dependent upon the void section  
15 that it cannot be presumed that this Board would have enacted the valid sections without the void  
16 ones, or unless the court finds that the valid sections standing alone are incomplete and are  
17 incapable of being executed in accordance with the legislative intent.
