

1 **BOARD BILL NO. 272 INTRODUCED BY ALDERWOMEN PHYLLIS YOUNG**
2 **AND APRIL FORD-GRIFFIN**

3 An Ordinance authorizing First Amendments to certain leases with Grace Hill Neighborhood
4 Health Centers, Inc. (“Grace Hill”) pertaining to changes in use and authorizing a federal interest
5 required by The Department of Health and Human Services (“HHS”) under a certain grant
6 authorization and containing an emergency clause.

7 WHEREAS, the City of St. Louis (“City”) by Ordinance No. 66745 entered into two (2) Lease
8 Agreements with Grace Hill, both dated October 21, 2005, to secure and provide primary
9 healthcare, wellness, child day care, adult day care and other social services and to lease the
10 operation of two (2) medical clinics in the City at 2200 Lemp or Max C. Starkloff Center and
11 1717 Biddle or Courtney Health Center (“Medical Clinics”); and

12 WHEREAS, Grace Hill desires to improve the Medical Clinics and to add certain related
13 administrative functions and its required information systems in addition to the aforementioned
14 services; and

15 WHEREAS, Grace Hill has secured a certain grant from HHS, Award No. C8ACS21253-01-00,
16 in the amount of approximately TWO MILLION ONE HUNDRED FORTY-SEVEN
17 THOUSAND EIGHT HUNDRED TWENTY-ONE DOLLARS (\$2,147,821.00) for
18 improvements to the Medical Clinics (“HHS Grant”); and

19 WHEREAS, HHS requires Grace Hill and the City to grant a federal interest in order to obtain
20 the HHS Grant in the nature of restrictive covenant wherein the Medical Clinics may not be used
21 for any purpose inconsistent with its current use as presently leased and amended herein and may
22 not mortgage or sell same, and;

1 WHEREAS, the City is willing to allow the improvements and changes in use and to grant a
2 federal interest with the understanding that said Medical Clinics shall continue to provide the
3 secured and provided services, as described herein.

4 **NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF ST. LOUIS AS FOLLOWS:**

5 SECTION ONE. Paragraph 2 of each Lease Agreement between the City and Grace
6 Hill is hereby amended by adding the following sentence at the end:

7 In addition to the uses described herein, Lessee may provide for certain related
8 administrative functions and for its required information systems.

9 SECTION TWO. In consideration of the improvements at each medical clinic, the
10 City hereby authorizes its Comptroller or her designee to execute a Notice of Federal Interest,
11 which shall state as follows:

12 The Notice of Award for this grant includes conditions on use of the aforementioned
13 property and provides for a continuing Federal interest in the property. Specifically, the
14 property may not be (1) used for any purpose inconsistent with the statute and any
15 program regulations governing the award under which the property was acquired; (2)
16 mortgaged or otherwise used as collateral without the written permission of the Associate
17 Administrator, Office of Federal Assistance Management (OFAM), Health Resources
18 and Services Administration (HRSA); or (3) sold or transferred to another party without
19 the written permission of the Associate Administrator, OFAM, HRSA. These conditions
20 are in accordance with the statutory provisions set forth in Affordable Care Act, Title 45
21 CFR part 74 or 92 as applicable, the HHS Grants Policy Statement, and other terms and
22 conditions of award.

23 These grant conditions and requirements cannot be nullified or voided though a transfer
24 of ownership. Therefore, advance notice of any proposed change in usage or ownership
25 must be provided to the Associate Administrator, OFAM, HRSA,

26 SECTION THREE. Emergency clause.
