

1 **BOARD BILL NO. 70CSAA INTRODUCED BY ALDERWOMAN CARA**  
2 **SPENCER, ALDERWOMAN CHRISTINE INGRASSIA, ALDERMAN SAMUEL**  
3 **MOORE, ALDERMAN CHRIS CARTER, and ALDERMAN SHANE COHN**

4 An ordinance calling and providing for the holding of an election in the City of St.  
5 Louis on November 8, 2016, for the purpose of submitting to the qualified voters of the  
6 City of St. Louis the question of charging a fee for the issuance of a permit for the  
7 operation of a Short-Term Loan Establishment, and directing the Clerk of the Board of  
8 Aldermen to notify the responsible election authorities of this election.

9 **WHEREAS**, the City has enacted ordinances for the regulation of Short-Term  
10 Loan Establishments; and

11 **WHEREAS**, the responsibilities and duties of regulating the Short-Term Loan  
12 Establishments require such services and activities as the inspection, regulation, and the  
13 issuance of a Short-Term Loan Establishment permit; and

14 **WHEREAS**, the City believes it is necessary that the City charge a reasonable fee  
15 to offset the services it provides and its activities in connection with its responsibilities  
16 and duties; and

17 **WHEREAS**, the City believes the cost to the City incurred by the services it  
18 provides and its activities in connection with its responsibilities and duties should be  
19 borne by those Short-Term Loan Establishments requiring or enjoying such services or  
20 activities.

1 **BE IT ORDAINED BY THE CITY OF ST. LOUIS AS FOLLOWS:**

2 **SECTION 1.** An election shall be held and the same is hereby called and ordered  
3 to be held in the City of St. Louis, Missouri on the 8th day of November, 2016, at which  
4 there shall be submitted to the qualified electors of said City, the proposition as  
5 hereinafter set forth in Section 3 of this ordinance.

6 **SECTION 2.** That the polling places in the various wards and precincts in the  
7 City of St. Louis whereat the said proposition shall be submitted to the qualified electors  
8 of said City shall be those polling places established or to be established by the Board of  
9 Election Commissioners for the City of St. Louis, as provided by law.

10 **SECTION 3.** The notice of the submission of the said proposition at the said  
11 election shall be given jointly by the said Board of Election Commissioners and by the  
12 City Register of the City of St. Louis by publication in the City Journal, the St. Louis  
13 Post-Dispatch, and in at least one other weekly newspaper serving citizens of the City of  
14 St. Louis, twice, the first publication occurring in the second week prior to the election  
15 and the second publication occurring within one (1) week prior to the election, which said  
16 notice shall be in substantially the following form:

17 Shall the City of St. Louis, Missouri, be authorized to impose an annual fee of  
18 \$5,000 for each permit (new or renewal) for a Short-Term Loan Establishment or \$2,500  
19 for a permit issued with less than 6 months remaining in the calendar year?

18 **SECTION 4.** The Board of Election Commissioners for the City of St. Louis,  
19 Missouri, shall provide the ballots, conduct the election, and certify the results of said  
20 election to the Board of Aldermen of the City of St. Louis, Missouri, as required by law.

21 **SECTION 5.** That immediately upon the passage and approval of this ordinance,  
22 the Clerk of the Board of Aldermen shall certify a copy thereof to the Board of Election  
23 Commissioners for the City of St. Louis, Missouri, for action and proceedings by said  
24 Board in accordance herewith and as required by law.

25 **SECTION 6.** This being an ordinance for the preservation of public peace, health  
26 and safety, and providing for submission to the people, it is hereby declared to be an  
June 28, 2016

1 emergency measure within the meaning of Sections 19 and 20 of Article IV of the  
2 Charter of the City of St. Louis and therefore this ordinance shall become effective  
3 immediately upon its passage and approval by the Mayor.
