

**COMMITTEE SUBSTITUTE
BOARD BILL NO. 2 INTRODUCED BY ALDERWOMAN BENNICE JONES-KING**

1 An ordinance prohibiting the issuance of any package or drink liquor licenses for any
2 currently non-licensed premises within the boundaries of the Twenty-First Ward Liquor Control
3 District, as established herein, for a period of three years from the effective date hereof; containing
4 an exception allowing, during the moratorium period, for the transfer of existing licenses, under
5 certain circumstances, and the issuance of a drink license to persons operating a restaurant at a
6 previously non-licensed premises; and containing an emergency clause.

7 **BE IT ORDAINED BY THE CITY OF ST. LOUIS AS FOLLOWS:**

8 **SECTION ONE. LEGISLATIVE FINDINGS.**

9 The existence of alcoholic beverage establishments appears to contribute directly to
10 numerous peace, health, safety and general welfare problems including loitering, littering, drug
11 trafficking, prostitution, public drunkenness, defacement and damaging of structures, pedestrian
12 obstructions, as well as traffic circulation, parking and noise problems on public streets and
13 neighborhood lots. The existence of such problems creates serious impacts on the health, safety and
14 welfare of residents of single- and multiple-family within the district, including fear for the safety
15 of children, elderly residents and of visitors to the district. The problems also contribute to the
16 deterioration of the neighborhood and concomitant devaluation of property and destruction of
17 community values and quality of life. The number of establishments selling alcoholic beverages and
18 the associated problems discourage more desirable and needed commercial uses in the area. In order
19 to preserve the residential character and the neighborhood-serving commercial uses of the area, there
20 shall be a moratorium on the issuance of new liquor licenses within the area beginning at the
21 intersection of the centerline of Vandeventer Ave. and Ashland Ave., and proceeding along the centerlines

1 in a generally clockwise direction west to Fair Ave., north to Lexington Ave., west to Marcus Ave., north
2 to Palm St., west to Shreve Ave., north to West Florissant Ave., southeast to Interstate 70, east to Adelaide
3 Ave., southwest to Rosalie St., southeast to Carter Ave., west to Fair Ave., south to Penrose St., east to Clay
4 Ave., south to Kossuth Ave., east to Prairie Ave., south along the road through Fairgrounds Park to
5 Vandeventer Ave., and south to the point of beginning. Such area shall be known as the Twenty-First
6 Ward Liquor Control Area.

7 **SECTION TWO.** The Excise Commissioner is hereby prohibited, for a period of three years,
8 beginning as of the effective date of this Ordinance, from approving the issuance of a package or
9 drink liquor license for any premises which is located within the boundaries of the Twenty-First Ward
10 Liquor Control District established in Section One of this ordinance.

11 **SECTION THREE.** Notwithstanding the provisions of Section Two of this Ordinance, the Excise
12 Commissioner shall have authority to:

13 (1) Approve transfer of an existing license to another premises within the petition
14 circle of the currently licensed premises, pursuant to the provisions of subsection (B) of section
15 14.06.330 of Ordinance 61289; and

16 (2) Issue a drink license for a premises which has operated as a restaurant, as such
17 term is defined in section 14.01.390 of Ordinance 61289, **for at least two quarters of a fiscal year**
18 **as determined by the gross receipts reported to the License Collector for the City of St. Louis.**

19 (3) Approve the renewal of an existing license under the provisions of Section
20 14.08.090 of Ordinance 62656.

21 **SECTION FOUR. EMERGENCY CLAUSE.**

22 This being an ordinance for the preservation of public peace, health and safety, it is

1 hereby declared to be an emergency measure within the meaning of Sections 19 and 20 of Article IV
2 of the Charter of the City of St. Louis and therefore this ordinance shall become effective immediately
3 upon its passage and approval by the Mayor.
