

1 **BOARD BILL NO. 485CS** **INTRODUCED BY ALDERMAN SAMUEL L.**
2 **MOORE**

3 An Ordinance repealing Ordinance 59973, approved January 15, 2008, and enacting a
4 new ordinance directing the Director of Streets to temporarily close, barricade, or otherwise
5 impede the flow of traffic on north Market Street at the east curb line of Marcus Avenue and on
6 Dick Gregory Place at the north curb line of Dr. Martin Luther King Drive **north 135 feet**;
7 remove, redirect and establish the direction of Aldine Avenue as a one way street from
8 eastbound to westbound; remove, redirect and establish the direction of Leduc as a one way
9 street from eastbound to westbound; remove, redirect and establish the direction of Cote
10 Brilliante Avenue as a one way street from westbound to eastbound and containing an
11 emergency clause.

12 **BE IT ORDAINED BY THE CITY OF ST. LOUIS AS FOLLOWS:**

13 **SECTION ONE.** Ordinance 59973, approved January 15, 2008 is hereby repealed and
14 enacted in lieu thereof is the following:

15 **SECTION TWO.** The Director of Streets is hereby authorized to temporarily close and
16 barricade the flow of traffic on North Market Street at the east curb line of Marcus Avenue and
17 on Dick Gregory Place at the north curb line of Dr. Martin Luther King Drive **north to a point**
18 **135 feet to the southern curb line of the east-west alley.**

19 **SECTION THREE.** The Director of Streets is hereby authorized to remove Aldine
20 Avenue as a one way street eastbound from Marcus Avenue to Dick Gregory Place and is
21 authorized to establish Aldine Avenue as a one way street westbound from Dick Gregory Place
22 to Marcus Avenue.

1 **SECTION FOUR.** The Director of Streets is hereby authorized to remove Leduc
2 Avenue as a one way street eastbound from Marcus Avenue to Dick Gregory Place and is
3 authorized to establish Leduc Avenue as a one way street westbound from Dick Gregory Place to
4 Marcus Avenue.

5 **SECTION FIVE.** The Director of Streets is hereby authorized to remove Cote Brilliante
6 Avenue as a one way street westbound from Dick Gregory Place to Marcus Avenue and is
7 authorized to establish Cote Brilliante as a one way street eastbound from Marcus Avenue to
8 Dick Gregory Place.

9 **SECTION SIX. EMERGENCY CLAUSE.** This being an Ordinance for the
10 preservation of public peace, health, and safety, it is hereby declared to be an emergency
11 measure within the meaning of Sections 19 and 20 of Article IV of the Charter of the City of St.
12 Louis and therefore this Ordinance shall become effective immediately upon its passage and
13 approval by the Mayor.
